## 8. PRINGLE SURNAME PROJECT

#### Tabled:

Report on the Pringle Y-DNA Surname Project.

#### Noted:

(1) Pringle Y-DNA Surname Project started in 2009 at DNA Heritage with Sir Murray as Administrator. In 2011 DNA Heritage was sold to Family Tree DNA and the Project run under

- World Families until November 2017 when the Project was transferred to The Family Tree DNA and Gail Riddell was appointed volunteer Administrator;
- (2) To date, 130 men have been tested in two stages, 21 in the DNA Heritage 43 marker test of which 12 are related in three lineages and 109 in FamilyTreeDNA with various marker tests. In the latter group, 33 are in four lineages are closely related to the Pringles of that Ilk and Stichill. Another 8 are related more distantly and are probably Smailholm descendants, making a total of five lineages.
- (3) Deep ancestry research proves that the ethnic origin of the Pringles is R1b-S21 Germanic (also known as R1b-U106) descending from the Northumbrian Angles. This corroborates Alexander Pringle's opinion that all three syllables of the surname 'Hop-ring-hill' are from 'Old English'. Historically, from the 7th century the Lothians and Borders were conquered by the Northumbrian Angles and made part of the Kingdom of Bernicia. Until Malcolm II, King of Scots conquered all of the land north of the Tweed in the 10th century.
